Every December the City of New Smyrna Beach hosts public strategic planning sessions to review progress made in the current year and set new Citywide goals for the year ahead. This year, City Commissioners have hired GAI Consultants' Community Solutions Group to facilitate this process and they're eager to hear what you have to say!

Two identical public meetings will be held on Thursday, Dec. 5 and Monday, Dec. 9 from 5:30 to 7:30 p.m. in the Brannon Center at 105 S Riverside Dr. to give city residents opportunities to meet the GAI team and, following a short 15-20 minute presentation, let them know what changes you'd like to see in New Smyrna Beach. They will then present their findings to City Commissioners at a separate public meeting in the Commission Chambers at City Hall on Thursday, Dec. 12 from 9 am to 4 pm.

The City Commission is scheduled to review the Economic Development Strategic Plan Update on December 10!

The Economic Development Advisory Board met on Wednesday, November 20 and recommended that the final draft of the City's Economic Development Strategic Plan Update for 2020 be forwarded to the City Commission for approval. The plan contains:

- The results of monthly meetings with business owners from April thru October, attended by 122 unique business representatives. The meetings were hosted jointly by the City and the Southeast Volusia Chamber of Commerce to hear speakers and respond to questions such as how the City and the Chamber can have a positive impact.
- The results of interviews with over 15 business owners representing all six industry sectors targeted for expansion and attraction (aviation/aerospace; creative class; manufacturing; medical; professional; recreation).

An update of the 2016 plan's three sections: Who We Are; Vision: An Enhancement of Who We Are; and The Action Plan

The Action Plan is organized to clearly indicate which actions would be taken by the Economic Development Advisory Board and staff, and which are recommendations for action by others. For example, a key recommendation is to have City Planning staff develop and bring forward a new "overlay" district for US 1 which will allow, as a permitted use, a broader variety of business types including craft and artisan food and beverage manufacturing, food processing, and the production of personal care products, all of which would typically be considered light manufacturing; however, the growing awareness of New Smyrna Beach as an exceptional location for food, beverage, and recreation experiences is attracting interest from those business types - and US 1 locations need to be positioned to quickly take full advantage. The current zoning and land development regulations for US 1 need to be addressed now to facilitate the improvements sought by these and other current market interests. This change in US 1 land development regulations – and the revision of the County's resolution for the Community Redevelopment Agency (CRA) to facilitate private property improvement grants – together provide the best path toward the long-awaited redevelopment of US 1.

Another recommendation in the Plan is to prioritize City Economic Development efforts on strengthening small businesses - by connecting small businesses to the resources available to help them grow (see the last page of this newsletter), assisting in navigating the permitting system, helping business start-ups, encouraging sustainable business practices, and exploring the concept of "franchise – free zones". Small, independent businesses are the heartbeat of the City's business community and one of the City's "signatures" - things that positively distinguish New Smyrna Beach.

- The branding of the Riverside Garden District and a discussion on how the City can brand commercial districts will be scheduled for the next meeting of the City's Economic Development Advisory Board will be held on Wednesday, January 15 at 6 pm in the City Commission Chambers.

On November 19 the City Commission approved Ordinance 80-19 authorizing a pilot program
providing for off-site sandwich board signs in the Mixed Use Zoning District under certain
conditions.

Private Property Projects

- Hyatt Place Hotel (proposed for the property behind Dunkin Donuts on Third Ave, the site of the vacant former retail center that included most recently an Outback Restaurant, now closed) – Site Plan under review.
- <u>Starbucks</u> (proposed for the site of the NSB Sea Shack Restaurant on Third Ave) Site Plan under review.
- <u>Tractor Supply</u> (proposed for SR44 at Corbin Park Rd, Southeast corner) permit has been issued. That area has a plat coming forward and scheduled for the December 10 City Commission meeting.
- Riverwalk Condos, NW area of North Causeway: construction continues on several buildings. One of the units was featured in the most recent Parade of Homes.
- <u>Canal Street Pavilion</u>: the former movie theatre space on the NE corner of Canal and Orange has been renovated. Owner Dick Rosedale has one office space upstairs still available for lease: 956-0668.
- New Commercial Building at 701 E Third at Saxon (east bound side of street): two units left to lease for professional office, retail, or restaurant: 690-1636.
- <u>Blue Ocean Dermatology</u> is constructing two professional office buildings at the NE corner of W Canal and Duss St.
- <u>Beacon Apartments at SR 44 and Glencoe Rd (SW corner)</u>: Development with 253 apartments, now under construction.
- Assisted Living Facility, 115 Washington St in Canal St area on Alba Court site: 104 bed facility now under construction.
- <u>Tabby House mixed use development between Canal St & City Hall</u>: 11 of the 17 lots are either complete or under construction.

City/County/State Projects

- The "Weeping Mortar Building" North of City Hall: This major renovation project is now underway and is scheduled for completion in about 12 months. The parking lot east of the building will be closed during construction. Following renovation this building will house the City Commission Chambers, and the Planning, Engineering, and Building departments which will move from their current location at 2650 US 1.
- New playground equipment at Pettis Park: Staff anticipates this project will be complete this month.
- FDOT project on US 1, from Julia to Andrews with significant work at the Canal St intersection: now under construction; completion scheduled for summer, 2020.
- 5th St. Bridge Replacement in coordination with FDOT: in design.
- Alonzo "Babe" James Community Center Splash Pad: This project is moving forward with bidding. It
 is anticipated that the Splash Pad will be complete by late summer, 2020.
- o Women's Club Building Improvements: in design.
- Old Fort Park Wall: design complete, bidding soon; partial grant funding approved.
- Public Parking lot to serve Pettis Park and the Black Heritage Museum: Property at the SE corner of Duss and Jefferson Streets has been purchased by the City's CRA for the planned construction of a public parking lot. The project is now in the final stages of design.
- Affordable Housing: FIRST DUPLEX COMPLETE at the corner of Julia and Dimmick Streets, a partnership with the NSB Housing Authority, Volusia County, and the City of New Smyrna Beach CRA. A second duplex is being planned.
