City Commission Regular Meeting Tuesday, January 23, 2024

Mayor Fred Cleveland called the meeting to order. In attendance were Vice Mayor Valli Perrine, Commissioners Lisa Martin, Jason McGuirk and Randy Hartman. Staff present were City Manager Khalid Resheidat, Assistant City Manager Ron Neibert, City Clerk Kelly McQuillen, and City Attorney Carrie Avallone.

CITY MANAGER'S REPORT

- City Manager and Police Chief met with Advent Health CEO to address mental health issues.
- City Manager met with Innovation Partners regarding the Rt. 44 Industrial Park. This will be a long planning process with an estimated plat submittal in February and final approval in August 2024.
- City Manager responded to previous public comments regarding the Cooper St. vacation that no orphan parcel will be left due to the vacation.

PUBLIC PARTICIPATION

- The owners of Upward Trend Academy, which serves children with disabilities, thanked the Commission for a rezoning request allowing them to move into a new facility. They also advised that their fundraiser brought in \$50,000.00.
- A citizen spoke of the need for a better process in decision making and coordination between the P&Z and the Commission in addition to having more citizen input.

ADMINISTRATIVE ITEMS/NEW BUSINESS

• **RFP Conditions for the Women's Club.** Assistant City Manager, Ron Nebert reported that per the Commission's request, staff prepared a Request for Proposal (RFP) for the sale of the Women's Club. The City received two appraisals for the

property. The average of these two appraisals is \$424,500 which is the recommended minimum bid proposed in the RFP. An additional RFP condition is that the structure "cannot be demolished and that the structure shall be rehabilitated" honoring the historical integrity of the building. The proposal due date is February 29, 2024 and proposal opening date is March 1, 2024. After some discussion, the motion for approval of the RFP in the form presented passed **unanimously.**

 A motion for approval of Strategic Government Resources, Inc.'s contract for Executive Search Firm for a City Manager passed unanimously.
